

**OFFICIAL WARNING
ANNUAL TOWN MEETING
STOWE VERMONT
MARCH 7, 2023**

The legal voters of the Town of Stowe are hereby notified and warned to meet at the Stowe High School Auditorium on TUESDAY, MARCH 7, 2023 at 8:00 AM to act upon any of the following articles not involving Australian Ballot:

NOTE: The Town of Stowe Annual Town Meeting will begin immediately following the Stowe School District Annual Meeting.

TOWN MEETING:

Article 1: Shall the voters approve a one percent sales tax to be used to support the General Fund?

Article 2: Shall the voters approve the Selectboard’s proposed General Fund Budget of sixteen million five hundred seventy-nine thousand seven hundred thirty-four dollars (\$16,579,734) of which twelve million eighty-four thousand two hundred thirty dollars (\$12,084,230) is to be raised by property taxes and four million four hundred ninety five thousand five hundred four dollars (\$4,495,504) is to be funded by other revenues?

Article 3: Shall the voters approve the Selectboard allocating six hundred thirty-five thousand dollars (\$635,000) of the accumulated Capital Fund for the following capital projects:

Stowe Town Plan Community Engagement	\$35,000
Bear Proof Trash and Recycling Containers	\$60,000
Public Safety Communications System Enhancement	\$175,000
Townwide Web Platform Consolidation	\$25,000
Town Clock Rehabilitation	\$95,000
Stormwater Catch Basin & Line	\$120,000
Streambank Stabilization – Rec Path Bridge 1	\$125,000

Article 4: Shall the voters approve compensating each of its five (5) Selectboard members three thousand dollars (\$3,000) for their service in the ensuing year, each of the three (3) Listers two hundred fifty dollars (\$250) for their service in the ensuing year, and the Moderator one hundred dollars (\$100) for each annual or special town meeting over which the moderator presides?

Article 5: Shall the voters authorize the Selectboard to enter into contracts with owners, lessees or operators of ‘farmland’ and “forestland,” as those terms are defined in 24 V.S.A. § 2741, to fix and maintain the valuation of such property in the Grand List?


Article 6: To hear and to act on the report of the Town officers and the Auditor's report for the budget period July 1, 2021 to June 30, 2022.


