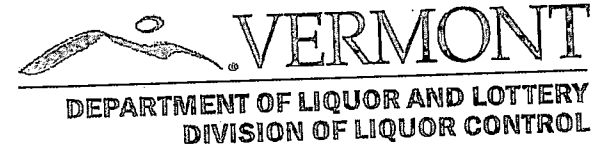

1. The area referred to in the application must be clearly defined by a description (such as "booth", "tent" etc. and include approximate size).
2. You must identify the price of alcoholic beverages to be sold including size of containers and limits on purchases.
3. The area referred to in the application must be adequately staffed, controlled and maintained at all times.
4. Service and consumption of alcohol products must be confined to the defined area.
5. Special Event Permits must be referred to the local control commissioners for consideration before sending to DLC.
6. All liquor control laws and regulations that apply to first and second class licenses will also apply to holders of Special Event Permits.
